

**FACTS****WHAT DOES Park Square Home Mortgage, LLC DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• <b>Social Security number</b> and <b>Account balances</b></li> <li>• <b>Payment history</b> and <b>Credit card or other debt</b></li> <li>• <b>Credit scores</b> and <b>Income</b></li> </ul>
<b>How?</b>	All financial companies need to share <b>Customers</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>Customers</b> personal information; the reasons <b>Park Square Home Mortgage, LLC</b> chooses to share; and whether you can limit this sharing.

## What we do

How does Park Square Home Mortgage, LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. **Installation of encrypted software, using password protection, and using web-based secured file share applications.**

How does Park Square Home Mortgage, LLC collect my personal information?

We collect your personal information, for example, when you

- **Apply for a loan** or
- **Give us your contact information** or
- **Give us your employment history** or
- **Give us your income information** or
- **Give us your wage statements**

**We also collect your personal information from others, such as credit bureaus, affiliates, or other companies**

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. **[See below for more on your rights under state law.]**

What happens when I limit sharing for an account I hold jointly with someone else?

**Your choices will apply to everyone on your account - unless you tell us otherwise**

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include financial companies such as FBC Home Insurance Services, LLC, Clear Title of Florida, LLC, PSH Title, LLC, FBC Mortgage, LLC, and common owners., Our affiliates include nonfinancial companies such as Accusured Management, LLC*

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Park Square Home Mortgage, LLC does not share with nonaffiliates so they can market to you.*

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Park Square Home Mortgage, LLC does not jointly market.*

## Other important information

**California Residents:** Unless you have given your express written consent, we will not share your personal information for our affiliates to market to you, for non-affiliates to market to you, or for joint marketing with other financial companies.

**Vermont Residents:** Unless you have given your express written consent, we will not share your personal information or creditworthiness for business purposes or for our affiliates to market to you, for non-affiliates to market to you, or for joint marketing with other financial companies.
